## RCONA October 2019 unofficial meeting notes by Ann Newberry

## old news updates:

New RCONA website is still not available for NA's to use their sections. No word on availability.

<u>Drawing districts for Roseville City Council elections.</u> This is on the agenda for the Oct. 23rd city council meeting.

## on the agenda:

<u>Police</u> Captain Troy Bergserom reported on progress in fulfilling pans made possible by Measure B:

- There are now 4 shifts of officers, with a minimum of 7 officers on each, and shifts overlap, so there are 2 officers on each beat.
- New beat boundaries were drawn to divide Beat 6 to add new Beat 7. There were a few
  other minor changes, with most beats unaffected. This was a data-driven process, mainly
  based on records of calls for service and reports made. Neighborhood Association
  boundaries were kept within 1 beat. New beats are in effect by February 2020 when new
  hiring will be complete.
- There are 7 motorcycles for traffic only.
- There are 5 Community Service officers.
- We have added 2 drone units in last 9 months, and there will be 3 new ones with night vision. These are not the drones that we can buy, and officers have to go through intensive training to use them by achieving FAA certification.

<u>Santa in the Neighborhood</u> routes will be available on November 1st; we can check on <u>rcona.com</u>.

Jim Kidd reported on Maidu neighborhood, the first of planned sharing.

SVNA is to share at the November meeting, after our Halloween gala.

RCONA member Bob Velcheck presented the tentative RCONA budget. (attached). His key points were:

- 1. There is no budget for Movies in the Park. NAs can do this on their own. We will be asked for interest at the November meeting.
- 2. He proposes that RCONA events should only be held if there is committed support from the NAs, in volunteers.
- 3. A welcome Wagon -type activity is suggested for RCONA. (I would like to make this happen in our own neighborhood.). Robert Sanchez provided a few bags with city freebies as examples. I got several, will bring to our next meeting.
- 4. There is a proposed budget for the RCONA HS senior scholarships to continue. Applications will be starting soon.
